

## Information on the Payment of Social Contributions

as per January 2026

In accordance with the enrollment regulations of TU Dortmund University, proof of payment of contributions and fees is required for enrollment or re-registration.

**Enrollment:** New students at TU Dortmund University will receive their payment information after applying for enrollment via the Campusportal. Thereafter, the payment information can be found inside the Campusportal of TU Dortmund University ([www.campus.tu-dortmund.de](http://www.campus.tu-dortmund.de)) via selecting the section labeled 'Student Services' and then 'Payments'.

**Re-registration:** Students will receive the request for re-registration via e-mail. The payment information can be found inside the Campusportal of TU Dortmund University ([www.campus.tu-dortmund.de](http://www.campus.tu-dortmund.de)) via selecting the section labeled 'Student Services' and then 'Payments'. The date of receipt of your semester contribution on the bank account of TU Dortmund University is decisive for meeting the re-registration deadline.
